3. COMMISSION BUSINESS

4. NCMA Academy Series Affirmative Action, Diversity, Equity and Inclusion (DEI), & Gender Inclusive Restrooms

- A. Introduction of roundtable discussion topics, and guest speakers
Chair Wyett did a quick intro and welcoming to guest speakers

- B. College of Southern Nevada Presentation
Joe Hassert, Communication professor of the College of Southern Nevada and Chair of the Gender and Sexuality Alliance, and Gavin Davis, disability resource provider at the Disability Center, College of Southern Nevada – Charleston Campus. Both guest speakers provided information on “All access restrooms” campaign, the importance of all access restrooms in public buildings, and the work of the Alliance at the College of Southern Nevada. Gavin Davis provided background information on the rights of transgender individuals have to utilize restrooms based on self-identified gender.
