G. Subcommittee Updates

Housing by Chair Wyett

Chair Wyett provided an update on a three-part series collaboration between Nevada Neighborhood Housing Services of Southern Nevada, NAACP, Alpha Phi Alpha and Legal Aid. She added that part two was focused on Housing, and part three was after you buy a home, and what is needed and what will occur.

The chair provided an update on two major bills that passed during this year's legislative session related to affordable housing.

- AB310 requiring the Housing Division of the Department of Business and Industry to develop and implement a supportive housing grant program, creating the Nevada Supportive Housing Development Fund in the State Treasury.
- AB448 revising the exemption from the real property transfer tax applicable to certain transfers of real property between business entities.
- Workforce Development None

Economic Development

In July 14th City of Las Vegas, Batteries Included Youth Initiative, Commissioner Navarro attended as a speaker and judge of the event. July 28th, Commissioner Navarro attended the Microbusiness Initiative with the Department of Business and industry; is a strategic business planning, assistance for housing, health, and education.

August 4th, Commissioner Navarro attended the United Way Hispanic Chapter meeting.

From August 30th to November 1st, Commissioner Navarro will be teaching an entrepreneurship master class on Wednesdays from 5:30pm to 8:30pm at the Nevada state Business Center.

Healthcare

Commissioner Gallagher has attended several meetings for the past month with the Department of Health and Human Services staff with an effort to collaborate with different agencies to see what resources are available for healthcare and see if those resources are helpful for them.

Commissioner Gallagher has also been referring stakeholders to the Commission's website as she connects with other entities.

Chair Wyett recently toured The Center, a minority serving organizations that is focused on serving the LGBTQ community, but their services are offered to all citizens. The majority of their clientele are Hispanics and African Americans.

Higher Education

Commissioner Lau stated that there are a lot of events going on at the collages in celebration of Hispanic Heritage Month.

On October 17th the University of Nevada Reno is having the state of the university. Commissioner Lau also stated that he was down in Southern Nevada visiting some of the colleges with an effort to connect with them.

K-12 Education

Commissioner West provided background information and an update on the recent release of the Nevada School Performance Framework (NSPF), school ratings, English Language Proficiency students, absenteeism, and graduation rates.

Chair Wyett asked if some of the statistics that were shared was an overall number or only for BIPOC communities.

Commissioner West clarified that it was an overall number.

Legislative

Chair Wyett stated Commissioner Romero is going to be taking a public policy course. Chair also stated that her and Commissioner Romero will be meeting with Asher Killian with LCB
